

EFFECTIVE APRIL 6, 2020

All health department clinic services and classes postponed until further notice.

The rise of novel coronavirus (COVID-19) existence and spread has resulted in a worldwide, national, and local concern. Our office has always been committed to the health and safety of patients, staff, and community, which is why we feel it is important to continue services, while limiting exposure.

Effective April 6, 2020, Johnson County Community Health Services implemented the following procedures to limit access and reduce exposure in our continued effort to #flattenthecurve:

- Screenings will occur, including temperature, upon access to building.
- We ask, that for your safety, all high risk patients with underlying conditions or 65+, please postpone appointments to a later date.
- The office is following all standard disinfection protocols of common areas, treatment rooms, including, but not limited to high-touch surfaces, such as doors handles, counters, faucets, and toilet handles.

VENDORS

- We ask that you contact our front office at 660-747-6121 upon arrival, and someone will meet you at the door.

PUBLIC HEALTH

- **ALL** Public Health clinic services and classes are cancelled until further notice.

VITAL RECORDS

- **Death Certificates and Birth Certificates limited to Mail Services only.**
- Certificates can be obtained through the mail and are normally sent out the same day the application is received if there are no discrepancies between the information provided on the application and that within the state system.
- **Mail-in requests MUST be notarized by an acceptable notary public.**
- Anyone experiencing an urgent need to obtain a certificate is required to call 660-747-6121.

WIC

- Access to Warrensburg WIC is by scheduled appointment ONLY. Tuesday Walk-in has been postponed until further notice.
- If appointment can be completed by telephone, our WIC staff will contact you.

- Formula exchanges and any other assistance will be processed the same as scheduled appointments.
- WIC satellite clinics in Holden and Knob Noster are cancelled until further notice.
- Car Seat checks are postponed until further notice.
- Upon arrival, contact our WIC front office at 660-747-2012 for further instruction. *(NOTE: Due to the volume of increased calls, we ask that you please be patient. We will respond as quickly as possible.)*

ENVIRONMENTAL HEALTH

- Food Handler Classes are cancelled indefinitely until further notice.
- Vendors requiring access to permits, please contact Environmental Health at 660-747-6121 ext. 258 to schedule an appointment.
